### **PetroWorth Closes Second Tranche of Financing**

Calgary, Alberta – PetroWorth Resources Inc. (CNQ:PTWR) (Frankfurt:T3F) is pleased to report that its second tranche of non-brokered private placement financing, previously announced on March 13, 2007, has closed. The financing was fully subscribed with gross proceeds totaling \$2.4 million upon the issuance of 4,000,000 common shares at \$0.60 per share.

The proceeds are intended to be used to conduct a concerted oil and gas exploration drilling campaign on the company's Eastern Canada properties, scheduled to commence this summer in New Brunswick and for general working capital requirements.

PetroWorth Resources Inc. is a junior oil and gas exploration company with extensive onshore properties in Eastern Canada. The Company has acquired 100% working interests in almost one million acres in nine separate exploration permits on Prince Edward Island, Nova Scotia and New Brunswick. The strategy of the company is to conduct aggressive exploration drilling programs on these permitted properties, both in-house and through advantageous farm-in arrangements.
